

**Mustang Basketball -2008-2009**  
**What you as a parent need to know(and agree to)**

- 1) I am responsible to pay and/or fund raise to cover all season fees. I have reviewed the fee schedule for 2008-2009. \_\_\_\_\_
- 2) I understand that my son or daughter's team may go to the National tournament in Springfield Missouri in March of 2009 (or the Texas state tournament). If my child decides to attend with the team, I will be responsible for those fees as well. \_\_\_\_\_

If I have questions about my child's playing time, I will ask the coach what my player needs to do to earn more playing time. \_\_\_\_\_
